## VENDOR INFORMATION

**BOOTH SPACE:** Booth spaces are approximately 10' x 10' and are assigned on a first-come, first-serve basis. Cost of one booth space is \$25.00.

*This is a rain or shine event. Vendors must provide their own leveling devices, tables, chairs, overhead cover, and anchors to secure cover in the event of inclement weather, water and extension cord, if needed. Booths are expected to be attractive and kept clean throughout the event. Some booths are located near sidewalks and walkways that are not part of vendor space and must be kept clear throughout the day.*

**ELECTRICITY:** Electricity is not available. You will need to provide your own power sources. Please bring battery operated or solar charged lighting for your booth as lighting in the Pickled Porch Cafe parking lot (location of Downtown Holiday Market – vendors) is limited to a couple of street lights and porch lighting. If you are a vendor utilizing a generator, it must be silent.

**FOOD BOOTHS:** Food vendors must comply with the Calaveras County Environmental Health Department guidelines. A copy of permit must be included with your application. **We are required to send registration information to the Environmental Department 2 weeks prior to the event.**

**EVENT HOURS, SETUP & TAKEDOWN:** The event hours are 4pm to 8pm. The Downtown Holiday Market will be located in the parking lot of the Pickled Porch Cafe in historic downtown Angels Camp, right on Main Street (Hwy 49). The area will be available at 2pm for vendors to drive in, unload and promptly remove your vehicle. Set-up must be complete by 3:45. There will be no admission of vendor vehicles between 4pm to 8pm. There is no take down of booths until the event is over at 8pm, unless directed to do so by a volunteer. All booth and related materials (including your trash) must be removed from Pickled Porch Cafe parking lot by 9pm. Ending time subject to change dependent upon weather and foot traffic.

**LIABILITY INSURANCE:** Each vendor is responsible for their own insurance and must include a copy of your liability insurance certificate with the following listed as additional insured: **Angels Camp Business Association / City of Angels.** The exhibitor expressly releases Angels Camp Business Association, City of Angels, Pickled Porch Cafe and volunteers and sponsors from any and all liability for any damage, injury or loss of any person or goods, which may arise from the rental and occupation of The Downtown Holiday Market space by the vendor, and vendor agrees to hold the The Downtown Holiday Market sponsors harmless of any loss by reason thereof. The sponsors of the event assume no risk.

**TAX:** Each vendor is responsible for sales tax when applicable. Please have your resale permit displayed in your booth.
